ARTICLE 1: This contract, hereby, has been issued according to 404/3 article of Code of Obligations considering the 14.03.2007 dated and 2007/4 numbered Circular Note of Directorate of Land Office of General Directorate of Land Registry and Cadastre of T.C. Ministry of Public Works and Settlement and is a labor follow up contract that shall be valid until the new arrangement. This labor follow up contract shall not have attorney agreement value between parties.

**ARTICLE 2:** Demand owners and labor follower shall together be responsible for the accuracy of the documents that are to be submitted for operation. If the value of the damages to be incurred and transfer value of the immovable asset shall be lower than council tax to be based for title deed fees, Demand owners and labor follower shall together be responsible for punitive and financial aspects.

ARTICLE 3: This labor follow up contract shall be for Alanya Chamber of Commerce and Industry. Demand owners and labor follower shall together be responsible for administrative, financial and punitive responsibilities that are to be incurred of any kind of information and document necessary for making operations. The duty of the responsible of the work (follower) is to prepare the operation ready for signing by taking the responsibility of following the document and the operation that are to be prepared within the process of completion of operation. It is obligatory to take attendance and signature of the related right holder or authorized for contract and registration after completing the documents required by demand.

ARTICLE 4: Together with this contract hereby, labor follower has to submit his identity given by Chamber of Commerce and Industry, chamber registration copy or certificate of authorization which shows that he/she is authorized to do real estate agency or deed transactions to . The first copy of this contract shall be kept by Title Deeds Registry Office, second copy shall be kept by employer, and third copy shall be kept by labor follower.

ARTICLE 5: This certificate shall not be used by anyone other than members of Alanya Chamber of Commerce and Industry. It shall not be copied, multiplied, deleted, scratched, marked and it shall not be used by unauthorized individuals. This contract shall be valid for two months within the date of confirmation. This time limit shall not be applied for foreign national individuals. Unconcluded contracts shall not be put into operation and archived.
